



This certifies _____, herein referred to as mare owner, has engaged in one service to stallion **MMR Jinx On Me** for the mare _____, reg. No. _____, breed _____, for the 2023 season at Holman Halter Horses, Hempstead, Tx. for the fee of _____.

Joe or Corina Holman are the Agent/Breeding Manager for the Stallion Owner Joseph Holman. The breeding season for this contract begins February 1st 2023 and closes May 31st, 2023.

This service is subject to the following:

1. The booking fee of \$500.00 (non refundable) is due, payable to Joe or Corina Holman. Balance due, payable to Joe or Corina Holman. before any semen will be shipped. No contract will be approved until fees are paid. A photocopy of the registration papers, both front and back must accompany this contract. If mare has more than one registry and you want a breeder's certificate for both, you must send both sets of papers.

2. Breeding days will be Monday, Wednesday, Friday.

We highly recommend sending your mare to a vet clinic or breeding farm for her heat cycle. They will coordinate optimum shipping times with us.

* All semen orders must be received by 8:00 pm CST the day before semen is to be shipped.

Shipping charges will be \$360.00 for overnight, \$400 for overnight Saturday delivery, \$550 for counter to counter. A \$65 fee will be charged for any unreturned semen shipping containers. Shipments picked up at Equine Partners Veterinary Services by the Mare Owner or authorized agent will be charges a \$210 collection fee.

3. Semen will be shipped on collection days only on an "as available" basis.

4. Live foal guarantee: Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if foal is stillborn, a return breeding will be guaranteed the following year only at the Breeder's facility providing proper notification is given. Proper notification is a written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare owner verified that such abortion or death did not result from any act or omission of the Owner. Rhino vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses through her pregnancy. Failure to do this will void Live Foal Guarantee.

5. Rebreds: If the mare does not produce a live foal the first breeding season bred, mare owner is entitled to a rebreed the following year after the initial year the breeding fee was paid. Thereafter, mare owner will be subject to an additional chute fee, plus any increases in the breeding fee. No live foal guarantees on the third year.

6. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal.

7. It is agreed that should above named stallion die or become unfit for service, contract shall become null and void.

8. 2% interest will be charged on all accounts in excess of thirty days.

9. The Breeding Season in force for this contract shall begin February 1st and close May 31st of the year on this contract.
